ILRC Family Preparedness Plan

"Every family should have a Family Preparedness Plan in case of an emergency. It is equally critical for immigrant families to think ahead and set more concrete plans for immigration emergencies that can arise.

To assist in this, we've provided a toolkit below that goes into detail about different childcare options available in case of an absent parent, where to find trusted immigration services in your community, and how to prepare to assert your constitutional rights in the presence of an immigration officer."

"No matter who is president, everyone living in the U.S. has certain basic rights under the U.S. Constitution. Undocumented immigrants have these rights, too. It is important that we all assert and protect our basic rights.

If you find you have to deal with Immigration and Customs Enforcement (ICE) or other law enforcement officers at home, on the street, or anywhere else, remember that you have the rights described in this factsheet. The factsheet also provides suggestions for what you should do to assert your rights."

iAmerica Know Your Rights Guide

A situational know-your-rights guide including what to do when someone is at your door, stops you in your car, or if you are detained as a US Citizen. Find <u>downloadable know-your</u> <u>-rights cards</u> and a know-your-rights app for <u>Apple</u> and <u>Android</u> that will read your rights out loud to an ICE or law enforcement agent and send a message to an emergency contact.
